EXPLAINING THE PROCESS

Every year, AFP-WV releases an updated version of our Pathway to Prosperity Legislative Agenda. The Pathway to Prosperity is a comprehensive policy agenda that is meant to act as a roadmap for policymakers. It embodies the proven policy solutions that will change the state's status quo and help our fellow Mountaineers reach their full potential. Launched in 2019, the policy agenda seeks to elevate and amplify the voices of West Virginians across the state who want to remove the barriers that are holding them back. We believe these issues put us on a path towards reigniting the American Dream in the Mountain State.

We work with legislative leaders of both parties to enact the much-needed reforms we outline in the Pathway to Prosperity. When one of these policies is up for a vote in committee or on the floor, we send a Key Vote Alert to every member of the legislature indicating our support for the bill being decided upon. In some instances, we ask lawmakers to vote against legislation that will be detrimental to creating the conditions for a new and stronger West Virginia in which everyone can reach their full potential.

At the same time, we advocate for policies during the session through the use of our Key Vote Alerts and by connecting citizens with their lawmakers on the issues at hand. We monitor how lawmakers vote, and we use our annual scorecard to let folks know how their elected officials voted on some of the most critical issues from each legislative session. This helps to increase government transparency, get citizens engaged in the legislative process, and to inform lawmakers on the issues.

BILL DESCRIPTIONS

HB 4432 | Relating to midlevel practitioners — Committee Amendment

Lead Sponsor: House Health Committee
AFP's Position: Oppose
Outcome: Failed
House RCS #17 | Senate RCS #N/A
The defeat of this committee amendment
ensured that the certified registered nurse
anesthetists provisions remained in the bill-

HB 4432 | Relating to midlevel practitioners — Passage

Lead Sponsor: Del. Amy Summers AFP's Position: Support Outcome: Passed House

House RCS #19 | Senate RCS #N/A

This bill would have made health care services in the state more reliable, affordable, and accessible by removing outdated and unnecessary government red tape for our hometown health care providers. It would have allowed physician assistants to own a practice and allowed Certified Registered Nurse Anesthetists (CRNAs) to practice to their full scope of training without in-person physician supervision requirements. West Virginia is one of only 10 states that does not let CRNAs practice to their full scope of training.

HB 4434 | Relating to restriction on use or sale of motor vehicles based on power source — Passage

Lead Sponsor: Del. Gary Howell AFP's Position: Support Outcome: Passed House House RCS #64 | Senate RCS #N/A

This bill would have ensured that no state or local government entity can prevent West Virginians from buying the type of car that they want to purchase. As President Joe Biden continues to try to push through harmful government mandates regulating energy usage as a part of his so-called Green New Deal, it is important that state policymakers send strong signals to Washington that our citizens will not be bullied by needless red tape that limits their freedoms. This bill should have been one of those signals, but did not complete legislative action.

HB 4945 | Relating generally to the Hope Scholarship Program — House Floor Amendment

Lead Sponsor: Del. Sean Hornbuckle AFP's Position: Oppose Outcome: Defeated House RCS #342 | Senate RCS #N/A

This amendment was one of many attacks on the Hope Scholarship Program to come from the radical left to undermine the transformational effect this program has had for West Virginia students and parents. If not soundly defeated, it would have hurt families who are either currently utilizing or eventually plan to participate in the Hope Scholarship because it would have limited the availability of education service providers, taking much needed options away from students and families.



SB 493 | Relating to use of criminal records as disqualification from authorization to practice particular profession — Passage

Lead Sponsor: Sen. Laura Wakim


Senate RCS #238 | House RCS #N/A

This bill would have made it easier for individuals with criminal records to pursue professional careers, and move past their past mistakes, by strengthening an existing law that prevents the denial of occupational licenses for certain offenses unrelated to the job's duties.

SB 503 | Protecting belief-based student organizations from certain types of discrimination — Passage

Lead Sponsor: Sen. Amy Grady AFP's Position: Support Outcome: Enacted Senate RCS # 282 | House RCS #663

The bill protects belief-based student organizations by expanding student organizations that are protected against certain types of discrimination by a state institution of higher education and expanding the types of discrimination the student organizations are protected from. The bill allows religious organizations on state campuses to choose leaders who believe in the tenets of their religion, and not be subjected to trolls and hecklers looking to shut the organization down with false claims of "discrimination."
